

## About the Deerfoot Lodge Missions Endorsement

Deerfoot has had an historic interest in world missions. Each session at camp, missionary work is promoted and an offering is taken to support missions. While Deerfoot never purposed to be a missionary training ground, many Deerfoot alumni who have gone into missionary service report that their Deerfoot experience was formative to their calling and preparation for missionary service. In recent times, Deerfoot staff that have chosen to serve in short-term missions service (one year or less) have looked to Deerfoot for help and encouragement in their venture.

Because the work of Missions is so broad in nature, there is a need to define Deerfoot's focus and objectives in missions' initiatives by creating a formal designation of Deerfoot endorsed missions' efforts to which Deerfoot will lend its support and commitment as the Lord leads us.

Generally, Deerfoot will endorse missionary efforts (individuals or organizations) that are international (though domestic missions may be considered on a case-by-case basis), camping oriented, and have a connection to Deerfoot (alumni, friend of camp). The objectives would be to

- Extend the reach of DL's mission to the international camping movement.
- Develop a network of relationships with like-minded missionary efforts where DL can focus its support.
- Expose DL staff and campers to missionary initiatives around the world and inspire them to be world-minded Christians.
- Build relationships with international camp movements that result in healthy exchanges of ideas, training, staff, and support.

Deerfoot Lodge's endorsement means:

1. DL offers its official non-financial support.
2. DL would promote or highlight an endorsed mission effort via its promotions (for example, an occasional spot in the Tracks, or link on the web site, etc.) and during the middle session Sunday service, when a missions offering is taken.
3. DL would decide whether or not to provide material or financial support to a missionary or organization on a case-by-case basis. Financial support would normally come from summer missionary offerings and would be a one time gift.
4. DL would encourage staff members to go and serve with endorsed missionaries or organizations. Such staff members, while going with DL's blessing, are responsible to apply to their own sending agency and raise their own support.
5. DL may share the expertise of its full-year staff or alumni (such as Chief Chuck, Chief Ron or Chief Ken) by sending or consulting with endorsed missionaries/organizations. Deerfoot financial support for travel expenses if needed would be decided by the Board on a case-by-case basis.
6. DL would permit endorsed missionaries and organizations to publicize that their ministry is endorsed by Deerfoot Lodge.

What Deerfoot Lodge's endorsement does not mean:

1. DL will stand in place of an official missions sending agency or Church.
2. DL will manage third party financial support for endorsed missionaries or organizations.
3. DL will provide ongoing salary, benefits or financial support of any kind for endorsed missionaries or organizations.
4. DL will presume directional authority over or responsibility for the activities of endorsed missionaries or organizations.
5. DL will use its mail lists for solicitation for raising support. The Director, however, may make the DL community aware of endorsed missionaries and provide contact information on a case-by-case basis.
6. DL will be held responsible for the well-being of endorsed missionaries.

Criteria for DL endorsement:

1. Endorsed missionaries must be DL alumni (former camper, staff, volunteer).
2. Endorsed organizations must have a purpose that complements the camp mission and values of Deerfoot. It is anticipated that most endorsed organizations will be international camps/adventure programs.
3. Endorsed organizations and missionaries must be in full agreement with the Deerfoot Lodge Statement of Faith.
4. Endorsed organizations and missionaries will be sent by a legally constituted sending agency or church.

Process for endorsement:

1. Upon request, the Director will provide an application for missions' endorsement.
2. The completed application will be reviewed by the Director who will determine if the applicant meets the criteria for endorsement and for recommendation to the DL Board of Directors.
3. If recommended by the Director, the application will be presented to the DL Board of Directors for endorsement approval.
4. An applicant can be endorsed by DL upon majority vote by the Board of Directors present at any one of the regular Board meetings (Spring, Summer, Fall).
