

2015 Voyager Allagash Description

Please read this description and the Windfall Rafting release to make sure this is the trip for you. Send a signed copy to Chief Ron ASAP to complete your registration.

Trip Summary: The Voyager Allagash Canoe trip is a 10 day trip for Campers, age 15-17, in Maine. Campers arrive on Changeover Saturday as per normal procedure. They will leave Camp for Maine in the first Sunday of the Session, then return on the final Thursday of the Session in time for Camp Fire. The trip activities include 10 days of camping, hiking Katahdin Mt (weather permitting), Canoeing the Allagash River, and one day of White Water rafting on the Kennebec River.

Pre-requisites and Qualifications:

- Strong Trail experience at Deerfoot (or comparable experience: Please call Chief Ron 518-256-0106).
- At least a Basic award in Canoeing at Deerfoot (or comparable: Please call Chief Ron 518-256-0106).
- Desire to work hard and endure the rigors of living on the trail (rain or shine!)
- Willing to be a team player and participate in camp site tasks, duties, etc.

Trip Details:

1. Maximum group size is 12 (two chiefs, 10 campers) At least one Chief will be 21 years old or older and hold certifications in WFA, CPR and Life Guarding. He will also be approved as a Maine Guide, which is required by the State of Maine.
2. Whitewater Rafting is provided by professional rafting company that is not affiliated with Deerfoot Lodge. A separate signed release is required by the rafting company.
3. The Group will climb Katahdin Mountain, weather permitting, on the first Tuesday of the Trip. Katahdin is a well known hiking destination that serves as one of the end points for the Appalachian Trail.
4. The Allagash River is remote wilderness. The Chiefs will carry a SPOT unit that allows them to signal for help in the event of an emergency. It should be noted that even satellite signal units can be unreliable.
5. Travel time is approximately 9-10 hours to the Allagash River region. The Travel route passes through Freeport Maine where the group may make a quick stop at some of the well-known outdoor gear outlets (LL Bean, etc.). Spending money is at your own discretion.
6. The basic trip schedule is as follows:
 - 1st Sunday-Travel Day. Pack up and leave camp. Overnight camping on the property of a DL family near Boston, MA.
 - 1st Monday-Travel Day. Travel to Baxter State Park, Maine (stop at LL Bean Outlet in Freeport, ME)
 - 1st Tuesday-Hike Day. Hike Katahdin Mountain.
 - 1st Wednesday-Put in on the Allagash River.
 - 1st Thursday-2nd Tuesday-Canoe Allagash River
 - 2nd Tuesday-Take out of river, travel to Moose River Outpost, Jackman, ME
 - 2nd Wednesday-Whitewater rafting on Kennebec River. Camp Fire with Seth Coates (Deerfoot alumnus and rafting guide)
 - 2nd Thursday-Travel Day-back to camp.
 - 2nd Friday-Saturday- Clean up, Banquet Night, go home.

After reading the above description, I am excited to be part to be part of the Voyager Allagash trip. I meet the pre-requisites and trip qualifications.

**USER PARTICIPATION AGREEMENT ASSUMPTION OF RISK, RELEASE OF LIABILITY
And MEDICAL TREATMENT AUTHORIZATION.

I am aware that during the whitewater expedition, climbing activities, hiking and or any other activity offered in which I am voluntarily participating under the arrangements of **DOWNEAST RAFTING INC., D.B.A ADVENTURE BOUND, INC., NORTHERN OUTDOORS, INC.**, their agents, employees and associates (hereinafter called "the Companies"), certain substantial risks and dangers exist or may occur, including but not limited to, (1) hazards of traveling on a raft or other whitewater craft in rough river conditions; (2) using paddles or oars and other whitewater equipment; (3) latent or apparent defects or conditions in equipment or property supplied by the Companies; (4) contact with plants or animals; (5) hiking in rugged terrain; (6) accident or illness in areas remote from medical facilities and first aid, emergency treatment or other services rendered; (7) the forces of nature and rapidly changing weather; (8) submerged, partially submerged and undercut rocks and manmade items; (9) changing currents and turbulent water conditions; (10) travel by automobile, bus, boat or other conveyance; (11) condition of roads, trails, waterways or terrain, and accidents connected with their use; and (12) consumption of food or drink.

I also understand that the above referenced activities can demand strenuous physical exertion which requires that I be in good physical health and I agree to disclose to the Companies their agents, employees and associates, and my trip leader or guide, any physical condition that may limit my participation in any of these activities, or any other activity provided by the Companies.

In consideration of and as part payment for the right to participate in any of the above referenced activities and services arranged for me by the Companies, **I UNDERSTAND AND EXPRESSLY ASSUME FOR MYSELF, MY HEIRS, ASSIGNS, LEGAL REPRESENTATIVES, EXECUTORS AND ADMINISTRATORS, ALL OF THE RISK AND DANGERS WHICH MAY BE ENCOUNTERED PRELIMINARY TO, DURING AND SUBSEQUENT TO THIS WHITEWATER EXPEDITION OR ANY OTHER ACTIVITY, I FURTHER RELEASE AND AGREE TO INDEMNIFY AND HOLD THE COMPANIES HARMLESS FROM ANY AND ALL LIABILITY, ACTIONS, CAUSES OF ACTION, AND CLAIMS OF ANY KIND OR NATURE WHATSOEVER. WHETHER FORESEEN OR UNFORSEEN, ARISING OUT OF MY PARTICIPATION IN THIS WHITEWATER EXPEDITION AND/OR ASSOCIATED ACTIVITIES ON ACCOUNT OF INJURY OR LOSS TO MY PERSONAL PROPERTY, EVEN INJURY RESULTING IN DEATH, WHETHER CAUSED BY NEGLIGENCE, BREACH OF CONTRACT OR OTHERWISE WHICH I MAY EVER HAVE AGAINST THE COMPANIES, THEIR SUCCESSORS, ASSIGNS, OFFICERS, DIRECTORS, SHAREHOLDERS, EMPLOYEES, OR AGENTS.**

I understand that the risks and dangers of participation may arise from foreseeable or unforeseeable causes including but not limited to negligence of the Companies, negligence of the participants, negligence of others, accidents, breaches of contract, the forces of nature and other causes.

In consideration of the Companies agreement to accept application, applicant hereby additionally releases Brookfield White Pine Hydro LLC, Outdoor Adventure Resorts LLC, River Wild LLC, Wagner Forest Management Ltd & ForesTree 96 LP, Katahdin Forest Management LLC, Central Maine Power Company, Inc., Kennebec Point, Inc., Great Lakes Hydro America LLC, Sustainable Forest Technologies, Mead Paper Co., Northern Outdoors Inc., Sawmill LLC and Pond Associates LLC, their servants, agents, employees, successors, and/or assigns from any claim for loss or injury of any kind, character or description which applicant may have arising out of participation in the activities of the Companies.

I also give my permission to use any and all written comments, pictures, video and/or movies in which I may appear for publicity, promotion and advertising on behalf of the Companies. The Venue of any dispute that may arise out of this agreement or otherwise between parties to which the Companies or its agents is a party shall be either the County of Somerset or State Supreme Court in Somerset County, Maine.

In recognition of the risks, which I am assuming by voluntarily participating in these activities, I hereby give the Companies, their agents and employees permission to treat me and to authorize medical treatment of me in the case of an emergency or accident. **I ALSO EXPRESSLY COVENANT AND AGREE NOT TO SUE THE COMPANIES OR THEIR AGENTS OR EMPLOYEES FOR ANY INJURY OR DAMAGES OF ANY KIND WHICH MAY OCCUR AS A RESULT OF THIS OUTDOOR RECREATIONAL ACTIVITY AND ACTIVITIES ASSOCIATED THEREWITH.**

I understand that I will be provided with additional information such as safety orientation and/or videotapes that will provide me with a good understanding of the risks surrounding whitewater rafting and any other outdoor activities provided by the Companies. I acknowledge that I am entitled to decide not to participate with the planned activity at any time up to and during the safety orientation and prior to entering the whitewater raft or any other specific activity. If I decide not to participate, I may be eligible for a partial refund at the company's discretion.
